Kylee's family started the Giving Tree to honor the memory and spirit of their 23-month-old daughter. She was killed in a tragic and unbelievable accident in 2000, leaving her family – including twin brother, Kevin – stunned, grieving and feeling helpless. "Kylee was so loved and so blessed, and this is our way of passing those blessings on to others," said Traci Lillich, Kylee's mother and Giving Tree President.

The Kylee Lillich Charitable Giving Tree is a non-profit 501c3, all-volunteer local charity that helps children year-round. Donations go to children who are hospitalized, grieving the loss of a parent, brother or sister, or simply in need of basic items. Referrals have come in from more than 30 schools and local hospitals. Professionals work with parents or guardians to determine the child's needs and make referrals. Most children ask for new warm clothes, new toys, new blankets and new baby items, and occasionally a bike or special wish is granted. The program began in Woodland at Lee Middle School where Kylee's aunt Tara Keegan helped organize an informal giving tree for needy Woodland students.
